21st Century International Arts Festival: Band Competition Rules & Regulations



1. Competition Categories

- a) Group A: Primary Schools
- b) Group B: Secondary Schools, Junior College & Pre-University
- c) Group C: Open Category

**Each band should have at least 26 participants, not inclusive of teachers and conductors.*

2. Music

- a) The contest performance consists of performance of 1 local piece, followed by the performance of 1 chosen composition.
- b) Please bring ORIGINAL scores, should verification be required.

3. Time Allocation

Total Stage Presence Time	No more than 20 minutes
Total Performing Time	No more than 15 minutes
Tuning on stage	No more than 2 minutes

4. Judging Criteria

- a) The maximum score is 100%.
- b) The adjudicator will judge the performance of both pieces according to the following major categories.
- c) Score:
 - 30% Sound (Tuning, Quality, Balance)
 - 40% Technique (Technique, Articulation, Ensemble playing, Rhythm)
 - 30% Musical Performance (Dynamics, Phrasing, Interpretation)

5. Allowance & Penalty

- a) Total performing time is 15 minutes. An allowance of 10 seconds will be given. 5% of the overall score will be deducted should stipulated performing time be exceeded.
- b) 5% of the overall score will be deducted for bands that report more than 10 minutes late.

6. On Stage Percussion & Instruments

- a) Participating groups are allowed to move percussion instruments on stage to suit your seating arrangements (subject to 20 minutes total stage presence time) EXCEPT Timpani, Chimes, Drum Set, Marimba, Xylophone and Vibraphone.
- b) Participating groups are NOT ALLOWED to remove/adjust the chairs onstage.
- c) Band is only allowed on stage after permission given by the Stage Manager.
- d) There will be NO assistance provided to bring percussion instruments onto the stage.
- e) There will be provision of 50 foldable music stands & 1 conductor stand.
- f) Piano will not be provided.
- g) All electronic musical equipment is not allowed. For example, Keyboard, Amplifier, Electric Guitar etc.

 - II. Technical Aspect: Tone Quality, Rhythm and Melodiousness
 - III. Overall Performance

6. Penalty

- a) If total performing time exceeds 15 seconds, 5% of the overall score will be deducted.
- b) 5% of the overall score will be deducted for groups that report more than 10 minutes late.

- a) Each group shall consist of a minimum of 8 dancers.
- b) All participants to provide their own music compact disc (CD), costumes and props.
- c) Dance music of good quality in single track CD format to be submitted to the organizer upon request. The CD is non-returnable. Please label the CD: School Name, Group Name, Dance Title & Length of Music.
- d) Live music accompaniment is allowed. Performing groups have to make their own instruments arrangement. Stage technical preparation should not exceed 1 minute.
- e) No backdrop, bulky or heavy props are allowed. No special stage effects and lighting design in allowed, stage arrangements should only be done by the organiser.
- f) Please ensure dance competition item and music does not infringe any copyright. The organiser reserves the rights to all recorded material.

- a) 10% of the final score will be deducted for any item that exceeds the stipulated time.

21st Century International Arts Festival: Choir Competition Rules & Regulations

1. Competition Categories

- a) Category A: Mixed Choir (SATB)
- b) Category B: Equal Voices Choir (SA or TB)
- c) Category C: Children's Choir (For ages 13 and below)
- d) Category D: Chamber Choir (No Age Limit)
- e) Category E: Folklore (No Age Limit)

2. Competition Criteria & Group Criteria

- a) Choirs competing in category C are NOT allowed to compete in Category B.
- b) Choirs competing in categories with age limits will be allowed to have 10% of the members bridging this age limit. The organizers reserve the right to check the age of singers and have the authority to make the final call.
- c) For every competition piece, choirs need to submit 7 original copies of the score to the organiser, of which, one copy will be kept in the festival archive after the competition. Photocopied scores of published works will not be accepted.
- d) Unauthorised audio and/or visual recording during competitions and concerts is strictly prohibited.
- e) No acoustic checks are allowed prior to the competition
- f) Decisions of the adjudicators are final and cannot be contested.
- g) Category Group Criteria:
 - Category A: Mixed Choir (SATB)

There should be a minimum of 25 singers in the choir *excluding* conductor *and/or* accompanists.
 - Category B: Equal Voices Choir (SA or TB)

There should be a minimum of 25 singers in the choir *excluding* conductor *and/or* accompanists.

Category C: Children's Choir (For ages 13 and below)

There should be a minimum of 24 singers in the choir *excluding* conductor *and/or* accompanists.

- Category D: Chamber Choir (No age limit)

There should be a minimum of 8 and maximum of 24 singers in the choir *excluding* conductor *and/or* accompanists.

- Category E: Folklore (No age limit)

There should be a minimum of 8 singers in the choir *excluding* conductor *and/or* accompanists.

3. Music

- a) No competition pieces are to be repeated.
- b) All competition pieces are to be approved by the artistic committee.
- c) Only live accompaniments are allowed. The use of any kind of playback or soundtrack is strictly prohibited.
- d) Original composition by composers born in the 20th century is to be performed in the original key except if the composer has given a written instructions concerning keys.
- e) Choirs that wish to sing in the transposed keys or the earlier works are to inform the festival office in advance and indicated on the score submitted.

Category A: Mixed Choir (SATB)

A1, Open Category (No Age Limit)

A2, Youth Category (For ages 19 and below)

- Ai. One *original choral composition/arrangement* from choir's home country or its cultural region;
- Aii. One *original composition/arrangement* **NOT** from choir's home country or its cultural region;
- Aiii. One freely chosen choral piece;
- Aiv. Minimum 1 song to be sung *a cappella*;

Category B: Equal Voices Choir (SA or TB)

B1, Open Category (No Age Limit)

B2, Youth Category (For ages 19 and below)

- Bi. One *original choral composition/arrangement* from choir's home country or its cultural region;
- Bii. One *original composition/arrangement* **NOT** from choir's home country or its cultural region;
- Biii. One freely chosen choral piece;
- Biv. Minimum 1 song to be sung *a cappella*;

Category C: Children's Choir (For ages 13 and below)

- Ci. One *original choral composition/arrangement* from choir's home country or its cultural region;
- Cii. One *original choral composition/arrangement* **NOT** from choir's home country or its cultural region;

Category D: Chamber Choir (No Age Limit)

- Ei. One *original choral composition/arrangement* from choir's home country or its cultural region;
- Eii. One *original composition/arrangement* **NOT** from choir's home country or its cultural region;
- Eiii. One freely chosen choral piece.
- Eiv. Minimum 1 song to be sung *a cappella*.

Category E: Folklore (No Age Limit)

- Fi. Two choral arrangements of folk songs from choir's home country or its cultural region should be sung.
- Fii. National costumes are welcomed.

- Ai. The total singing time for 3 songs *must not* exceed 15 minutes for A1 and 12 minutes for A2;

Ei. The total singing time for 3 songs *must not* exceed 15 minutes.

6. Penalty

- a) Singing time during the competition is to be strictly observed. Choirs that exceed singing time will be penalized. For every 15 seconds exceeded, 5% of the total points will be deducted.

- 7.3. The organizers reserve the right not to award any of the prizes should the entries in the judges’ opinion fail to meet the required standards.
- 7.4. The organizers reserves the right to make necessary amendments to the “Rules and Regulations” without prior notice.
- 7.5. With respect to the professional team of judges, all judge’s decision will be final and no further correspondence will be entertained.
- 7.6. Once entry form is submitted, changes of title/type/category etc are not encouraged and subject to approval by the organizer.
- 7.7. The festival office reserves the right to reject applications for artistic or organizational reasons. Any fees paid will only be refunded should the group be rejected.
